#### **SUB: - REGARDING CHANGE OF BRANCH.**

Subsequently, the Committee constituted by the Competent Authority reviewed the matter and has submitted its report.

The Institute has received total Ten (10) Applications till 31<sup>st</sup> July 2020 requesting for change of branch from ECE to CSE. Out of 10, Eight (08) students are found eligible and Two (02) students are found not-eligible for branch change as per the criterion.
