#### Admission to B.Tech through JoSAA 2020

Pursuant to issue of the fresh guidelines from CSAB/JoSAA and in suppression of the Notice dated 4<sup>th</sup> Nov. 2020, the students seeking admission in Indian Institute of Information Technology, Nagpur for the Academic Session 2020-21 are advised to note the following revised instructions & schedule for Institute Reporting:

1.	Mode of Institute Reporting	<b>Online Only</b> The students/parents are not required to physically visit the Institute for reporting.
2.	Mode of Institute Registration	<b>Online Only</b> The Registration & Enrolment Process shall be undertaken through a Link which will be uploaded on the Website of the Institute viz. <a href="http://www.iiitn.ac.in">www.iiitn.ac.in</a> before the start of registration process.
