**Job Description:** Primarily Teaching along with Academic, Administrative, Student Activities and Research related functions.

**Reporting To:** Associate Dean / Head of the Department or as advised from time to time.

Candidates who have completed defense for the PhD before closing date for the receipt of the Application Forms will have to attach the Certificate / Notification mentioning that Candidate is declared eligible for award of PhD Degree wherever applicable.

**Desirable Experience:** Minimum one year will be preferred in Teaching / Research / Industry.

**Desirable Requirement:** Candidate having PhD from CFTIs like IITs, NITs, IIITs, INIs etc will be preferred. The persons with higher qualifications & good academic record shall be given preference.

**Consolidated Salary:** Rs. 65,000/- per Month (For PhD Holders)  
Rs. 60,000/- per Month (For Non-PhD Holders)

2. IIITN encourages its Faculty Members for active research, consultancy and skill enhancement training for revenue generation. Candidates who are qualified and are having such skills, capabilities resulting in revenue generation, institute brand development are most encouraged to apply.
3. The Institute may offer Bachelor / Family Accommodation on chargeable basis to selected candidate, if available.

**4. General Information & Instructions:**

- a) The posts are on purely temporary basis and contractual basis initially for 11 Months. The extension of the tenure shall be based on Performance and shall be at the sole discretion of the Director, IIITN.
- b) The Institute reserves the right to terminate the services of the candidate any time by giving one month's notice, without assigning any reason. However, the Institute may, in lieu of such notice, pay the appointee an amount equivalent to one month's salary. Similarly, the appointee may also terminate his services by giving the Institute one calendar months' notice in writing or salary in lieu thereof.
- c) The Institute reserves the right to reject any / all application(s) and/or cancel the advertisement in whole or in part without citing any reason at any stage of processing.
- d) The Institute reserves the right to increase or decrease the number of posts to be filled as per the sole discretion of the Director, IIITN.
- e) No TA / DA and / or Lodging / Boarding will be paid for attending the Written Test/Interview. No accommodation shall be provided.

- h) Candidates are advised to fill the Online Prescribed Application Form within the stipulated time. The Recruitment Portal shall be closed on due date & time. The candidates would have to upload the relevant supporting documents online.

Further, the Candidate will have to bring the original and one set of self-attested photocopies of documents at the time of interview, date of which shall be intimated to the eligible candidate in due course.

- i) At the time of verification of documents, if documents are not as per Institute's criteria or originals are not presented then candidate will not be allowed to attend Interview / selection shall be cancelled. Hiding information or submitting false information will lead to cancellation of candidature at any stage of recruitment.
